UPDATE: MEDICAL BENEFITS FOR INDEPENDENT PRACTICES

In response to MLHPP interest, DVACO is developing a medical benefits product to offer our independent practices. Based on the long-term advantages, including lower cost and multiple plan offerings, DVACO and its consultants recommend a Multiple Employer Welfare Arrangement (MEWA). The timeframe for offering the product is sometime in 2020. As more information is available, it will be communicated via email and through this newsletter.
