CARES Act Provider Relief Fund

The CARES Act Provider Relief Fund (PRF) offers financial support to healthcare providers who have experienced lost revenues and/or expenses attributable to COVID-19. To date, HHS has distributed over \$175 billion through prior General and Targeted Distributions. Healthcare providers can now apply for additional payments from Phase 3 General Distribution of the CARES Act PRF.

HHS has also recently released their "Post-Payment Notice of Reporting Requirements" for providers that received funds exceeding \$10,000 from one or more payments from the Provider Relief Fund. These requirements can be found here.

Phase 3 General Distributions

1. Type of Program

a. Grant

2. Eligibility

- a. HHS is making a large number of providers eligible for Phase 3 General Distribution funding, including, but not limited to:
 - i. Providers who previously received, rejected or accepted a General Distribution PRF payments
 - Providers that have already received payments of approximately 2% of annual revenue from patient care may submit more information to become eligible for an additional payments
 - ii. Behavioral Health providers, including those that previously received funding and new providers
 - iii. Healthcare providers that began practicing 1/1/20 3/31/20
 - This includes Medicare, Medicaid, CHIP, dentists, assisted living facilities and behavioral health providers

3. Payment Methodology

a. All eligible providers will be considered for payment against the below criteria:

- i. All provider submissions will be reviewed to confirm they have received a Provider Relief Fund payment equal to approximately 2 percent of patient care revenue from prior general distributions
 - Applicants that have not yet received PRF payments of 2% of patient revenue will receive a payment that, when combined with prior payments (if any), equals 2% of patient care revenue
- ii. With the remaining balance of the \$20 billion budget, HRSA will then calculate an equitable add-on payment that considers the following:
 - A provider's change in operating revenues from patient care
 - A provider's change in operating expenses from patient care, including expenses incurred related to coronavirus
 - Payments already received through prior Provider Relief Fund distributions

4. Application Details

- a. Providers are encouraged to apply early to expedite the distribution of all payments
 - i. Link to the application and attestation portal
- b. Eligible providers can submit application, TIN and financial information between 10/5/20 11/6/20 at 11:59 p.m. ET for consideration for Phase 3 PRF

5. Miscellaneous

- a. Applicants must meet all of the following requirements in order to apply:
 - i. Filed a federal income tax return for fiscal years 2017, 2018, 2019 if in operation before 1/1/20; or be exempt from filing a return
 - ii. Provided patient care after 1/31/20
 - Patient care includes health care, services, and support, as provided in a medical setting, at home, or in the community
 - iii. Did not permanently cease providing patient care directly or indirectly
 - iv. For individuals providing care before 1/1/20, have gross receipts or sales from patient care reported on Form 1040 (or other tax form)
- b. Receipt of funds from SBA and FEMA for coronavirus recovery or of Medicaid HCBS retainer payments does not preclude a healthcare provider from being eligible
- c. HHS will host webinars to assist providers through the application process and the call center is also available to address questions
